1. Amending Resolution and Budget Authorization providing for the acceptance and expenditure of funds in the amount of \$45,000 for CIP 212124 Oral Health Program.

2. Amending Resolution and Budget Authorization providing for the acceptance and expenditure of funds in the amount of \$7,899.79 for CIP 811122-ARPA Community Event and Activation Grant (CEAG).

Matthew Normand, City Clerk, stated there has been some updated information that was provided this afternoon by Chairman Morgan and Director Belanger. They are looking to take the balance of those funds, which total \$15,936 and split it evenly between the Mill on Green Condominium Association, which is what is on your agenda, and the Safari Youth Club upon submission of necessary application documents.
